






Section 4. First Aid Measures

4.1 Description of first aid measures

Eye Contact: Check for and remove contact lenses. Immediately flush eyes with copious amounts of water and get immediate medical attention.

Skin Contact: Remove contaminated clothing and wash contact area with mild soap and copious amounts of water. Get immediate medical attention.
