Specificity: This antibody recognizes a protein of ~50kDa which is identified as Glial Fibrillary Acidic Protein

(GFAP). It shows no cross-reaction with other intermediate filament proteins.

Background: GFAP is specifically found in astroglia. GFAP is a very popular marker for localizing benign

astrocyte and neoplastic cells of glial origin in the central nervous system. An antibody to GFAP

is useful in differentiating primary gliomas from metastatic lesions in the brain and for

documenting astrocytic differentiation in tumors outside the CNS.

Species Reactivity: Human, Mouse, Rat, Cow, Pig, Rabbit, and Chicken. Others not known.

Positive Control: Brain or Astrocytoma.

Cellular Localization: Cytoplasmic

Titer/ Working Dilution: Immunohistochemistry (Frozen and Formalin-fixed): 0.5-1 µg/ml



Procedure:

- 1. Tissue Section Pretreatment (Required): Staining of formalin fixed, paraffin embedded tissue sections is significantly enhanced by pretreatment with Citrate Plus (ScyTek catalog# CPL500).
- Primary Antibody Incubation Time: We suggest an incubation period of 30 minutes at room temperature. 2. However, depending upon the fixation conditions and the staining system employed, optimal incubation should be determined by the user.
- 3. Visualization: For maximum staining intensity we recommend the "CRF Anti-Polyvalent HRP Polymer (DAB) Lab Pack" (ScyTek catalog# CPP125, see IFU for instructions).

Precautions:

Contains Sodium Azide as a preservative (0.09% w/v).

Do not pipette by mouth.

Avoid contact of reagents and specimens with skin and mucous membranes.

Avoid microbial contamination of reagents or increased nonspecific staining may occur.
